Personal data that we process

Seasogood BV processes your personal data as a result of your use of our services and/or
because you provide us with these data yourself.

Below you will find all the personal data we process:

mail or by telephone.

Special and/or sensitive personal data that we process

Our website and/or service is not intended to collect information about website visitors who
are under 16 years of age unless they have permission from their parents or guardians.
However, we cannot verify whether a visitor is over 16 years of age. We therefore
recommend that parents be involved in the online activities of their children in order to

For what purpose and based on what grounds do we process personal data?

Seasogood BV processes your personal data to be able to call or e-mail you if this is
necessary to perform our services.

Automated decision making

Seasogood BV does not make decisions based on automated processing that could have
(significant) consequences for individuals. These decisions are made by computer
programmes or systems, without the involvement of a third party (e.g. an employee of
Seasogood BV).

How long we keep personal data

Seasogood BV will keep your personal data no longer than strictly necessary to realise the
purposes for which your data are collected. We use a maximum period of 1 year to keep
personal data.

Sharing of personal data with third parties

Seasogood BV will not sell your details to third parties and will only provide them if necessary for the execution of our agreement with you or to comply with a statutory obligation. We have concluded a processor's agreement with companies that process your details on our behalf to ensure the same level of security and confidentiality of your details. Seasogood BV will remain responsible for this processing.

Cookies, or similar technologies, that we use

Seasogood BV uses functional, analytical and tracking cookies. A cookie is a small text file that will be saved in the browser of your computer, tablet or smartphone when you visit this website for the first time. Seasogood BV uses cookies with a purely technical functionality. They ensure that the website works properly and that, for instance, your preferences are remembered. These cookies are also used to make the website work properly and to optimise it. In addition, we place cookies that track your surfing behaviour so that we can offer you tailor-made content and advertisements.

When you first visited our website, we informed you about these cookies and asked your permission to place them.

You can opt out of cookies by configuring your internet browser so that it does not store any more cookies. In addition, you can delete all information that has previously been stored using your browser settings.
